4.1. Description of first aid measures

First-aid measures general	: Check the vital functions. Keep victim at rest in half upright position. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Vomiting: prevent asphyxia/aspiration pneumonia. Victim in shock: on his back with legs slightly raised. Keep watching the victim. Give psychological aid. Prevent cooling by covering the victim (no warming up). Keep the victim calm, avoid physical strain. If necessary seek medical advice.
First-aid measures after inhalation	: If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.
First-aid measures after skin contact	: After contact with skin, take off immediately all contaminated clothing, and wash immediately with plenty of water and soap. If skin irritation or rash occurs: Get medical advice/attention.
First-aid measures after eye contact	: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
First-aid measures after ingestion	: Rinse mouth. Do NOT induce vomiting. Call a POISON CENTER or doctor/physician if you feel unwell. Ingestion of large quantities: immediately to hospital.
